34/25 HIGHWAYS/HIGHWAY MAINTENANCE

Cllr G. Moore reported that Cllr R. Cockburn had advised that no action had been taken to resolve the issues with the drains at High Ireby and there are two pot holes on the High Ireby to Ruthwaite road.

Cllr G. Moore advised he had reported the issue with the drains at Aughertree which had previously been reported. An issue with the drain below Croft House had also been reported.

A report had been received that the road surface on the hill leading down to the crossroads in Uldale is deteriorating.

Cllr P. Normington reported that the road surface on the Torpenhow lonning towards New Park is wearing away.

35/25 COMMUNITY LED PLAN

Cllr P. Normington reported that the drop-in session held on 10 May had been a success with over 50 people attending and lots of suggestions put forward. By the end of the day, 13 people had expressed an interest in taking the Community-Led Plan forward. Two meetings had been held on 2 and 16 June, and agreement had been reached to take the Plan forward with a Chair, Treasurer and Secretary appointed to a Steering Group. To meet the costs involved in producing the Plan, £500 has been ring-fenced by the Parish Council with match funding of £500 awarded from ACT, of which 75% (£375) has been requested by the Parish Council at present.

The email from the Development Officer at ACT regarding working with the Parish Councillors to gather views and information relevant to the Lake District Local Plan and how the Local Plan meets the Parish's needs was discussed. ACT has already been working with the School and will be engaging with the WI and Globe Hall. It was agreed to defer a decision on how to progress this to the next meeting.

36/25 BUS SERVICE

This item was deferred until the next meeting.

37/25 TREE MAINTENANCE

A decision on this item was deferred to the next meeting.

38/25 DEFIBRILLATORS - IREBY AND ULDALE

It was noted that a replacement battery had been purchased for the defibrillator in Ireby and the pads for the defibrillator in Uldale will expire in September. It was also noted that there is an issue with the light in the cabinet at Ireby. A decision whether the cabinet should be replaced was deferred to the next meeting.

39/25 CUMBERLAND WARD BOUNDARY REVIEW - DRAFT RECOMMENDATIONS

The Local Government Boundary Commission for England has published the draft recommendations for new wards, ward boundaries, and ward names for Cumberland Council. The LGBC are now inviting comments on the recommendations.
